**Notice of Special Meeting of the Electors of the
Town of Bass Lake, Sawyer County**

Notice is hereby given that on Monday, November 13th, 2006, immediately following completion of the Public Hearing on the Proposed 2007 Budget, a Special Town Meeting of the electors called pursuant to Section 60.12 (1)(c) of Wisconsin Statutes by the Town Board for the following purposes will be held:

- 1.) To approve the total 2006 highway expenditures for 2007 pursuant to Sec. 82.01(3) of Wisconsin Statutes.
- 2.) To set compensation of elected town officials for the term of office beginning April 2007 through April 2009 pursuant to Section 60.10 (1)(b) of Wisconsin Statutes.
- 3.) To adopt the 2006 town tax levy to be paid in 2007 pursuant to Section 60.10(1)(a) of Wisconsin Statutes.

* Note: 2006 General Property Tax included Personal Property Taxes Collected. The actual 2006 Budgeted Levy was \$329,553.

The Proposed Public Meeting will take place at 7:45 p.m. following the regular monthly meeting of the Board of Supervisors. Immediately following upon the completion of the Public Hearing, a Special Town Meeting of the Electors will convene. Immediately following the Special Town Meeting, a Special Town Board Meeting will convene for the purpose of adopting the 2007 budget. If needed, we will reconvene into the Regular Town Board Monthly Meeting.
